# **Utilities Element**

### **Utilities Element**



#### Goals and policies address utilities in the City:



- Water: City Water Utility, Northshore Utility District, Woodinville Water District
- Sewer: City Sewer Utility, Northshore Utility District, Woodinville Water District
- Surface water: City
- Solid waste & recycling collection: City contracts with Waste Management
- Solid waste transfer: King County Solid Waste Division
- Electricity & natural gas: PSE
- Petroleum pipelines: BP Pipelines North America
- Wireless, wired telephone, cable TV, and broadband internet service: private companies
- Fiber-optic network: The City and its partners, and private companies

### **Draft Utilities Goals & Policies**





- Incorporate utility/energy conservation, sustainability, consideration of climate-related impacts
- Promote transition to renewable energy while ensuring electric grid is stable & can support needs
- Support ways to make installing EV chargers/infrastructure easier
- Support installation of EV chargers in public rights-ofway & at City-owned facilities and parks
- Make it easier for people to reuse, repair, compost

### Draft Utilities Goals & Policies



- Prioritize removing fish passage barriers for public projects
- Support internet access for underserved communities
- Revise levels of service to point to relevant functional plans
- Update to policy about Houghton Transfer Station to reflect proposed Northeast Recycling Transfer Station (under environmental review; County decision)



## Proposed Revisions since PC Briefing



- Revised goal about water to describe what high quality water means
- Deleted Policy U-5.5
- Deleted Policy U-6.1
- Revised goal addressing renewable energy to also emphasize electric grid stability
- Add personal electric mobility devices to EV policy
- Added educational programs and incentives to composting/recycling policy
- Minor revisions to address PSE and WA Department of Fish & Wildlife comments



## Public Services Element

### Public Services Element





Goals & policies address fire and emergency medical services, emergency management, police protection, solid waste collection and transfer, schools, and libraries.

- Fire & emergency medical: City
- Emergency management: City
- Police: City
- Public schools: Lake Washington School District (LWSD)
- Libraries: King County Library System

### Draft Public Services Goals & Policies



- Coordinate with LWSD to increase public school capacity & explore opportunity to create housing on properties
- Support people experiencing mental/behavioral health challenges
- Ensure City received fair allocation of tax revenue for services
- Explore options to help Fire/EMS navigate difficult to access locations
- Foster multi-purpose public facilities
- Build positive relationships community, Police, Fire

## Proposed Revisions since PC Briefing



- Added emphasis on active transportation connections
- New policy on supporting initiatives that promote housing affordability so that City employees have the option to live in Kirkland
- Revised LWSD coordination policy to include recreation and other community needs
- New policy on coordinating with utility providers and local fire departments to lessen the risk and impact of wildfires



# Capital Facilities Element

### Capital Facilities Element





- Sets the goals and policies for capital facility planning (6-years) for the City
- Capital facilities are City-owned structures, improvements, pieces of equipment, or other fixed assets (including land) with a useful life greater than 10-years and cost \$50,000 or greater (except for land)
- The Element contains a list of capital projects with estimated costs and methods of financing

# Draft Capital Facilities Goals & Policie





- Update policies to align with regional and GMA requirements;
- Update policies to more closely align the element with the Sustainability, Climate and Environment Element; and
- Incorporate public health and equity with the element update.
- \*Future hearing will cover updates to the Capital Facility Plan tables listing long-range capital and transportation projects to 2044.

## Proposed Revisions since PC Briefing





- Incorporated feedback from Planning Commission to Policies CF-2.1 and CF-2.2
- Additional administrative amendments from other City departments feedback

### **Transportation Policy Areas**

#### **SAFETY**

- Update policy for setting speed limits
- Build projects that provide greater separation between transportation modes
- Evaluate crash data and near-misses to identify future safety projects
- Promote safe behavior

#### **SUSTAINABILITY AND EQUITY**

- Create an equitable transportation system that provides mobility for all people while prioritizing the needs of the most vulnerable users
- Minimize transportation environmental impacts
- Ensure adequate resources to preserve and maintain the existing and future transportation system

#### **MULTIMODAL**

- Build connected networks
- Make walking, rolling, and bicycling safer, easier, accessible, and more convenient
- Connect people to transit and support projects for greater transit speed and reliability, advocate for increased transit service
- Ensure the transportation system is efficient and connected

#### LINK TO LAND USE AND BUILD PARTNERSHIPS

- Ensure future growth is supported and sustained by a livable, walkable, connected, and transit-oriented city
- Coordinate with a broad range of groups—public and private—to help meet Kirkland's transportation goals.

### Implementing the Transportation Element

the Transportation Element Chapter):

Includes goals, policies, project list (CFP) and sums the chapters of the TSP

The Comp Plan will point to more detail in the TSP



Includes detailed analysis of existing and future conditions, prioritization process for projects, greater detail.

The TSP will point to modal plans for more specific information (specific design, sidewalk gap analysis, etc.)

### Implementation Chapter



#### **Methods Section revised:**

- Include updating Neighborhood Plans annually if requested by community as part of the CAR process
- Could move this section to Introductions Chapter

### Strategies Section: Why does staff proposed deleting?

- Individual Elements include actions, programs to implement policies
- Work Programs change annually
- Functional Management Plans include implementation actions



# Draft Supplemental Environmental Impact Statement

### Existing Plan (No Action) Alternative




- Maintains current zoning and adopted plans (Kirkland 2035 Comprehensive Plan, NE 85th Street Station Area Plan/Planned Action, and adopted neighborhood plans);
- Maintains planned transportation projects;
- Does not include implementation of state mandates required by HB 1110

### Growth (Action) Alternative



- Additional residential capacity above growth targets for housing choices;
- Greater residential and commercial density, near transit corridors, commercial centers and implements regulations to encourage production of affordable, market-rate housing;
- Implementation with future multimodal improvements in Transportation Strategic Plan;
- Required state legislation for "middle" housing in all residential zones citywide;
   additional middle housing typologies in residential zones (HB 1110); and
- Consideration of proposed land use changes at sites in Juanita and Totem Lake;
   frequent transit routes.
