Proposal: Jonathan Whorley, the applicant, is requesting a Process I and Substantial Development Permit for subdivision of a single 29,083 SF parcel into two (2) single family lots in the RSA 4 zone and Holmes Point Overlay. The Washington State Department of Ecology has final approval of shoreline permits. The application was received by the City on April 06, 2022 and was deemed complete on August 26, 2024.

Location: <u>13034 Holmes Point Drive NE</u> located within the NE quarter of Section 26 of Township 26 N., Range 4 E.W.M., in Kirkland, King County Washington.

Neighborhood: Finn Hill

Review Process: The decision on this application will be made by the Director of Planning and Building. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Planning and Building Director will also receive a report from the Planning and Building Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Shoreline Master Program.

Public Comment: Comments may be provided in writing only. To be considered, written comments must be received prior to 5:00 PM on October 7, 2024. A copy of the Planning and Building Director's decision will be mailed to those providing written comments before the comment deadline. Others may obtain copies from the Planning and Building Department.

APPEALS: The Planning and Building Director's decision may be appealed to the State Shorelines Hearings Board only by the applicant or those who submitted written comments by the comment deadline. Additional information about how to appeal will appear in the staff report and Planning and Building Director's decision.
