



# City of Kirkland Notice of Application And Optional SEPA notice

Yip Boat Lifts, Case No. SHR24-00200 & SEP24-00269

**Proposal:** Seaborn Pile Driving, the applicant, is requesting a Substantial Development permit to install one boat lift and relocate one boat lift. The Washington State Department of Ecology has final approval of shoreline permits. The application was received by the City on May 23, 2024 and was deemed complete on June 5, 2024.

**Location:** 215 Lake St S located within the NW quarter of Section 8 of Township 25 N., Range 5 E.W.M., in

Kirkland, King County Washington.

**Neighborhood:** Moss Bay

#### **Review Process:**

The decision on this application will be made by the Director of Planning and Building. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Planning and Building Director will also receive a report from the Planning and Building Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Shoreline Master Program and other applicable codes.

**Environmental Review**: The City of Kirkland has reviewed the proposal for probable adverse environmental impacts and expects to issue a determination of non-significance (DNS) for this project. The optional DNS process in WAC 197-11-355 and KMC 24.02.170 is being used. This process integrates the comment period for the Notice of Application and SEPA. **This may be the only opportunity to comment on the environmental impacts of the proposal.** 

Agencies, tribes and the public are encouraged to review and comment on the proposed project and its probable environmental impacts. Comments must be submitted by July 1, 2024 to Martha Rubardt.

(Optional) The following conditions have been identified that may be used to mitigate the adverse environmental impacts of the proposal.

In the event that mitigation measures are proposed after the close of the integrated comment period, notice shall be given as required in KMC 24.02.160. the DNS or MDNS will not be issued until the comment period is over. A copy of the DNS or MDNS for the proposal stating the time period for filing an appeal may be obtained upon request.

Public Comment: Comments may be provided in writing only. To be considered, written comments must be received prior to 5:00 PM on July 1, 2024. Send written comments to project planner, Martha Rubardt, 123 Fifth Avenue, Kirkland, WA 98033 or to e-mail mrubardt@kirklandwa.gov. Please indicate your name, mailing address, e-mail address and refer to permit number SHR24-00200. A copy of the Planning and

Building Director's decision will be mailed to those providing written comments before the comment deadline. Others may obtain copies from the Planning and Building Department.

APPEALS: The Planning and Building Director's decision may be appealed to the State Shoreline Hearings Board only by the applicant or those who submitted written comments by the comment deadline. Additional information about how to appeal will appear in the staff report and Planning and Building Director's decision.


#### Alternate Formats:
