**Proposal:** DRG Development Inc., the applicant, is requesting to divide one 53,993 SF parcel into 7 parcels of 7052 SF, 7043 SF, 7215 SF, 7406 SF, 7422 SF, 7164 SF, and 7274 SF in the RSX 7.2 Zone. The application was received by the City on May 13, 2024, and was deemed complete on May 28, 2024.

## Neighborhood: Bridle Trails

**Review Process:** The decision on this application will be made by the Director of Planning and Building. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Planning and Building Director will also receive a report from the Planning and Building Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Subdivision Code and other applicable codes.

Public Comment: Comments may be provided in writing only. To be considered, written comments must be received prior to 5:00 PM on June 24, 2024. A copy of the Planning and Building Director's decision will be mailed to those providing written comments before the comment deadline. Others may obtain copies from the Planning and Building Department.

**APPEALS:** The Planning and Building Director's decision may be appealed to the Hearing Examiner only by the applicant or those who submitted written comments by the comment deadline. Additional information about how to appeal will appear in the staff report and Planning and Building Director's decision.


