

RESOLUTION R-5631

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND DECLARING THE CITY'S COMMITMENT TO ADDRESSING HOMELESSNESS THROUGH A PERSON-CENTERED APPROACH AND AUTHORIZING THE CITY MANAGER TO DEVELOP A HOMELESSNESS CONTINUUM OF CARE ACTION PLAN FOR NEW POLICIES, PROGRAMS, AND SERVICES THAT PREVENT AND RESPOND TO UNSHELTERED HOMELESSNESS IN KIRKLAND.

1           WHEREAS, the City Council's Goals include both 'Attainable  
2 Housing', to provide access to housing and encourage the construction  
3 and preservation of housing stock that meet a diverse range of incomes  
4 and needs, and 'Supportive Human Services,' to meet basic human  
5 needs, help people through economic and personal crises, help  
6 individuals thrive, and strive to remove barriers to allow all equal  
7 opportunities to succeed; and  
8

9           WHEREAS, ensuring access to safe and stable places to live is  
10 foundational for creating a community where everyone belongs; and  
11

12           WHEREAS, the City Council desires that the experience of  
13 homelessness be rare, brief, and non-recurring in the city and has made  
14 significant investments over time in local and regional housing and  
15 homelessness projects and programs to accomplish this goal; and  
16

17           WHEREAS, in 2023, the City Manager convened an  
18 interdepartmental team, titled the Coordinated Response to  
19 Homelessness Team, consisting of leadership across numerous City  
20 departments to ensure interdepartmental coordination, streamline  
21 processes, and maximize resources across the homelessness response  
22 system; and  
23

24           WHEREAS, the City is in the midst of a major update of its  
25 Comprehensive Plan, including both the Housing and Human Services  
26 Elements, with a focus on creating new and enhanced policies to foster  
27 the creation of more affordable housing units in Kirkland and to support  
28 the City's response to homelessness; and  
29

30           WHEREAS, the Coordinated Response to Homelessness Team  
31 prioritizes a person-centered and compassionate approach when  
32 considering situations involving unhoused community members while  
33 also ensuring the safety of unhoused persons, housed neighbors,  
34 businesses, visitors, and responding staff; and  
35

36           WHEREAS, the United States Court of Appeals for the Ninth  
37 Circuit has made several rulings cautioning cities against taking actions  
38 to criminalize homelessness, including enforcement of overnight  
39 camping bans on public spaces unless nearby shelter is available, and

40 the Supreme Court of the United States is reviewing these decisions in  
41 2024; and

42  
43 WHEREAS, the City of Kirkland's Homeless Outreach  
44 Coordinator engaged 124 households representing 160 individuals  
45 experiencing homelessness in 2023, the most recent Point-in-Time  
46 Count showed a 23% increase in homelessness in King County from  
47 2022 to 2024, and there is growing concern that the rising cost of  
48 housing will continue to exacerbate the rate at which individuals enter  
49 homelessness for the first time; and

50  
51 WHEREAS, other jurisdictions in King County have seen rapid  
52 increases of unhoused residents camping in public spaces and have  
53 urged all cities to proactively prepare to respond to such increases; and

54  
55 WHEREAS, the City Council remains committed to ensuring  
56 public spaces in Kirkland are safe, accessible, and enjoyed by all; and

57  
58 WHEREAS, the City Council affirms that the City of Kirkland is  
59 not a regional homelessness service provider such as King County  
60 government, the King County Regional Homelessness Authority, and  
61 regional non-profit organizations, and that the actions identified through  
62 this resolution are intended to support those experiencing  
63 homelessness in Kirkland and connect them to regional services; and

64  
65 WHEREAS, the City Council recognizes it needs to make  
66 concurrent investments in programs, policies, and services along the  
67 housing and homelessness continuum of care to keep Kirkland a  
68 belonging community enjoyed by all and a place where community  
69 members experiencing housing instability have access to resources  
70 needed to thrive, with the goal that homelessness is rare, brief, and non-  
71 recurring.

72  
73 NOW, THEREFORE, be it resolved by the City Council of the  
74 City of Kirkland as follows:

75  
76 Section 1. The City Manager is hereby authorized and directed  
77 to create a Homelessness Continuum of Care Action Plan to be  
78 presented for Council consideration by December 31, 2024.

79  
80 Section 2. The Homelessness Continuum of Care Action Plan  
81 shall provide objectives and actions to support, at minimum, the  
82 following identified policy goal areas:

- 83  
84 a. Prevent homelessness where possible through continued  
85 investment in prevention programs and support of legislation that  
86 creates and retains additional affordable housing units.  
87  
88 b. When homelessness occurs, support unhoused individuals in  
89 their transition back to stable housing through relationship-  
90 building and re-connecting to resources.  
91  
92 c. Provide a compassionate and dynamic response to situations  
93 involving unhoused residents, acting on a case-by-case basis to

- 95 best meet the unhoused individual's needs with dignity and  
 96 respect.  
 97
- 98 d. Provide timely Homelessness Assistance Response Team  
 99 contact with those experiencing homelessness when notified by  
 100 anyone submitting non-emergency reports of unhoused  
 101 individuals, provide prompt acknowledgment to those submitting  
 102 the reports, and explore alternative pathways for the community  
 103 to activate the Homeless Assistance and Response Team such  
 104 as a dedicated phone line, phone apps and web-based  
 105 activation.  
 106
- 107 e. Collaborate among City departments and with key community  
 108 and regional partners at every stage of the continuum of care,  
 109 leveraging the unique resources provided by faith-based groups,  
 110 regional service providers, A Regional Coalition for Housing  
 111 (ARCH), the King County Regional Homelessness Authority,  
 112 King County's Permanent Supportive Housing programs on the  
 113 Eastside, and other community partners and avoid duplication of  
 114 services.  
 115
- 116 f. Invest in a spectrum of policy and program options to create  
 117 choice and accountability for unhoused community members,  
 118 including policies for enforcement action if shelter space or  
 119 alternative locations are available and other strategies are not  
 120 effective.  
 121
- 122 g. Investigate and build on learnings and best practices from other  
 123 communities that have implemented programs, policies, and  
 124 services along the housing and homelessness continuum of  
 125 care.  
 126
- 127 h. If enforcement action becomes necessary, utilize enforcement  
 128 policies that will prioritize the safety of staff, the unhoused  
 129 individual, surrounding housed and unhoused community  
 130 members, businesses, and prevent negative impacts to public  
 131 lands, critical areas, and waterways.  
 132
- 133 i. Identify both local and regional short, medium, and long-term  
 134 funding strategies to accomplish each of the goal areas.  
 135

136 Section 3. In developing the Homelessness Continuum of Care  
 137 Action Plan, including identifying service needs and designing new  
 138 programs, the City Manager shall collect feedback from key  
 139 stakeholders including, but not limited to, residents, faith-based groups,  
 140 service providers, neighboring jurisdictions, landlords, regional housing  
 141 and homelessness groups, active and past participants of Kirkland  
 142 homelessness programs to incorporate voices with lived experience,  
 143 businesses, the Kirkland Downtown Association, the Kirkland Chamber  
 144 of Commerce, the Lake Washington School District, and the Lake  
 145 Washington Institute of Technology. The City Manager shall use any  
 146 public education and engagement tools necessary to collect this


146 feedback including convening town halls and public forums related to  
147 the Action Plan.

148  
149 Section 4. To support the development of the Homelessness  
150 Continuum of Care Action Plan, the City Manager is authorized and  
151 directed to:


- 152
- 153 a. Evaluate and refine homelessness data collection strategies to
- 154 right-size solutions to meet Kirkland-specific community needs.
- 155
- 156 b. Prepare issue papers on homelessness response system gaps
- 157 and potential responses to a rapid influx of individuals
- 158 experiencing homelessness identified by the Coordinated
- 159 Response to Homelessness Team to be included with the 2025-
- 160 2026 budget transmittal.
- 161
- 162 c. Evaluate potential funding sources and prepare service
- 163 packages for the 2025-2026 budget process at tiered levels of
- 164 investment for Council consideration.
- 165
- 166 d. Compile summaries of other actions the City has taken related
- 167 to homelessness to include in the Action Plan to support
- 168 comprehensive tracking, evaluation, and reporting to the Council
- 169 and the community.
