RECOMMENDATION

That the Human Services Commission understand the grant recommendation framework and funding available in preparation of developing 23-24 grant funding recommendations for City Council.

BACKGROUND DISCUSSION

Human services grant funding supports adopted City Council goals. The Human Services Element of the Comprehensive Plan states that it is a city goal to "create a community in which all members have the ability to meet their basic physical, economic and social needs, and the opportunity to enhance their quality of life."

A. History of Human Services Grant Funding

In 1986, the City of Kirkland began funding community agencies to provide human services to Kirkland residents. These general fund dollars have been one of two types of funding. The first are dollars that are assumed to be in each budget, called "ongoing base budget" dollars. Some years, the City Council has agreed to provide additional funding to meet increased human service needs. These funds are not guaranteed to be available in future biennium. These dollars are referred to as "one-time" supplemental funding. The ongoing base budget for human services for 2023 is \$969,237. In 2021, the City Council authorized one-time funding in the amount of \$241,889.

The City of Kirkland has added several sources of funding streams to support human services for Kirkland residents over the last few biennium cycles. Table 1 summarizes the investment since 2013 below.

Community Development Block Grant (CDBG)

Since it became a Joint Agreement City in the King County Urban Consortium in 2015, the City has been able to allocate part of its share of the public services funds from federal Community Development Block Grant (CDBG) program. The estimated amount for 2023 is \$41,785.

Enhanced Police Services and Community Safety Ballot Measure (Prop 1)

In 2018 Kirkland voters approved a 0.1% public safety sales tax that provided additional funding for police and human services initiatives, including enhanced police services, school resource officers, a Mental Health Professional and second Neighborhood Resource Officer, a gun safety program, and human services funding to address homelessness, mental health needs, domestic violence, and suicide prevention for youth. Earlier this year, an additional \$186,000 was allocated to human services funding following a program modification to the <u>School Resource Officer (SRO) program</u>. The funding available to support human services grants for 2023 is expected to be \$636,000.

Multi Family Tax Credit Agreement with Kirkland Sustainable (MFTE)

In the fall of 2019, the City entered into an agreement with Kirkland Sustainable Investments, LLC (KSI) to offer new affordable rental housing units and City (and other public sector) employee rental housing units in downtown Kirkland. Part of this agreement called for "the payment to the City of 65% of KSI's property tax savings for use by the City to invest in low-income housing programs and in support of the Eastside Women and Family Shelter." Over the last three year of this agreement the City has supported housing navigators and client move-in assistance to families and women staying at the new Kirkland Place for Families and Women. The estimated funding available for 2023 is expected to be \$76,440.

Here is a summary of the 23-24 budget for human services grant funding.

B. Application and Review Process

In April 2022, the City received 2023-2024 grant applications from community agencies requesting support for the critical services that help to meet the basic and emergency needs of Kirkland residents. Both the number of applications and the total amount requested significantly increased from the previous biennium.

Application Comparison:

Of the 109 programs seeking funding, 45 are new programs, representing 27% of the total amount requested for 2023-2024.

64 programs are returning for funding, representing 73% of the total ask for 2023-2024. The average increase in ask from the previous biennium is 94%. Requested amounts range from 0 to over 700% increase in total ask from programs previously awarded funding in 2021-2022.

Goal Area Investment Comparison:

The City of Kirkland allocates funding in five community goal areas for human services funding.

- 1. Food to Eat and a Roof Overhead
- 2. Supportive Relationships within Families, Neighborhoods and Communities
- 3. Safe Haven from All Forms of Violence and Abuse
- 4. Health Care to Be as Physically and Mentally Fit as Possible
- 5. Education and Job Skills to Lead an Independent Life

In addition to the specified goal areas, the Human Services Commission (HSC) discusses the specific needs of the community emerging at the time of considering the next cycle of human services grants. Making recommendations on what programs to fund is difficult, recognizing the valuable services each respective organization provides to the community. Commission priorities have historically included: affordable housing, rent assistance, health services, behavioral health

services, food insecurity, and lack of childcare. The pandemic has also prioritized the need to invest in community connections' focused programs.

Since the 2019-2020 biennium, the percentage of investment per goal area and the Commission priority areas have led to higher investments in housing and food, physical and mental health, and supportive relationships in the community. Table 2 describes the average investment per goal area by percentage for the last two cycles. Table 3 provides totals and number of programs by goal area for the last two cycles.

The Commission priorities were defined at the <u>January 2022 HSC meeting</u> for use with the 2023-2024 grant application review process, including:

- Improve knowledge and access to behavioral health services
- Support retention of behavioral health clinicians
- Address food insecurity
- Support living wages for front-line workers
- Invest in affordable housing and rent assistance
- Support affordable childcare
- Improve access to health services
- Invest in by/for organizations supporting communities disproportionately impacted by racism
- Create opportunities for people to connect during the pandemic

C. Current Applications

Following an extensive review process of the 109 applications received, the Commission is considering 84 programs for funding. 19 applications are no longer being considered. 6 applications require additional follow-up before the Commission decides to consider funding the programs. Refer to **Attachment A** for a summary of all applications' current standing.

Of the 84 programs being considered for funding, the total ask is \$3,979,368 for the 2023-2024 cycle. The 6 programs that require follow-up is \$148,378. Refer to Table 4 for a summary.

The 2023-2024 budget for human services funding is \$1,723,462, leaving a gap of \$2,255,906 in program requests of applications currently being considered for funding. The Commission can put together an Option B and Option C for Council consideration of additional one-time funding, but the draft recommendations for Option A must reflect what is currently budgeted for human services funding and subsequently, address the highest priority needs of the City and Commission.

Funding Structure Recommendation

Staff recommend the following to determine which programs are highest priority for the Commission at the August 10th meeting:

- *Earmark allocation amounts by goal area and priority* The proposed earmark per goal area is summarized in Table 5 below.
- Assess new programs against goal areas and Commission priorities
- *Review sub-categories to assess duplication of services* The sub-category list and definitions are included in **Attachment B**.
